NOTE: Newly accredited trauma centers will have their participation fee prorated for the year they became accredited.

Tri-Code Fee - Payable by December 30, 2016. \$764

- The Tri-Code fee is a licensing fee for the use of the Tri-Code injury encoding software which is a built in component to the Collector registry software. All levels of accredited trauma centers pay the same licensing fee.

Application Fee - Payable with Application Submission (Site Survey or Consultative Visit)

New Applicants or One-Year Centers:

- Adult or Pediatric Level I or II \$6,615
- Adult Level III \$5,513
- Adult Level IV \$3,150

Accredited Trauma Centers:

- Adult (Level I, II or III) or Pediatrics (Level I or II) \$3,308

Site Survey Fee – Payable January 31, 2017.

NOTES:

- *Site survey fee is based on the number of required surveyors. A hospital may elect to have additional site surveyors join a team for an additional cost. Please speak to the Director of Accreditation for additional details if applicable.

- *For all new applicants, half of the site survey or consultative visit fee must be paid by July 1st of the year prior to your anticipated survey/consultative visit date, and should accompany the letter of request for the visit.

- *For all applicants who have completed a consultative visit and elect to advance to a full site survey, the site survey fee is due January 31st.*
