

**Policy:**

It is the policy of the Pennsylvania Trauma Systems Foundation (PTSF) to identify criteria for site surveyor selection that assures appropriate expertise and supports the PTSF conflict of interest policy.

**Team Composition:**

PTSF staff will strive to develop teams comprised of surveyors from like level Trauma centers that are being surveyed. Team composition based on trauma center level is noted below.

\*Level IV Trauma Centers: When possible, the specialty of the Team Leader will match the specialty of the TPMD at the institution.

### General Guidelines:

1. Geographic Restrictions:
  - a. Level I and Level II Trauma Centers:
    - i. Surveyors must reside and work outside of Pennsylvania.
  - b. Level III Trauma Centers:
    - i. At least one member of the survey team must work and reside outside of Pennsylvania.
  - c. Level IV Trauma Centers:
    - i. The survey team may work/reside in Pennsylvania.
2. There will be no business or patient care relationship or any potential conflict of interest between the surveyor and/or the surveyor's place of employment and the applicant/applicant healthcare facility being surveyed.
3. In-state surveyors must work/reside at least 100 miles from the applicant hospital.
4. Surveyors who move from the state meet eligibility requirements after three years, but not in the competitive market where they had previously worked or lived.
5. There is no restriction in the number of times a surveyor may return to re-survey an applicant hospital. This is limited only by an objection of the applicant hospital.
6. Refer to Policy BD-106: Conflicts of Interest for additional clarifications.

### Surveyor Qualifications:

#### Surgeons:

- Board Certified (in accordance with PTSF Standards)
- Minimum of five years trauma experience, after completing residency
- For the Trauma Surgeon Team Leader: Previous PTSF survey experience preferred. If this is not possible, previous survey experience with another organization or state is required
- Trauma center experience within the last five (5) years, which may include functioning in a consultative role

#### Emergency Medicine and Subspecialists:

- Board Certified (in accordance with PTSF Standards)
- Minimum of five years of subspecialty experience in a trauma center
- Trauma center experience within the last five (5) years, which may include functioning in a consultative role

#### Registered Nurse:

- Trauma Program Management or Trauma Performance Improvement experience
- Minimum of the three years trauma experience
- Clinical experience in ED or ICU preferred
- Trauma center experience within the last five (5) years, which may include functioning in a consultative role
